#### **Definitions**

##### **Contest:**

Corona Summer Contest is a contest in which Qualified Entrants can make a Qualified Entry for a chance to win a Prize, with NO PURCHASE NECESSARY.

##### **Draw:**

A draw for a Prize on a Draw Date at a Draw Time.

##### **Drawn Entrant:**

Qualified Entrant whose Qualified Entry is randomly selected as a result of a Draw.

##### **Entry Period:**

The period beginning on 06/11/2025 at 12:00:00 PM ET and ending on 08/25/2025 at 3:00:00 AM ET.

**Prizes:**

**Qualified Entrant:**

An individual who is 19 years of age or older, resident of British Columbia or Ontario and holds a valid passport for travel to the United States and Colombia, but does not include:

1. No purchase necessary. No purchase necessary option is outlined below.

3. No Purchase Necessary Option: Qualified Entrants may submit a short and unique 50-word essay (an "Essay") on the topic of travel to Colombia as an alternative method of entry. One Essay is eligible for two (2) QR codes.

#### **How to Win a Prize:**

1. The odds of winning a Prize will depend on the total number of Qualified Entries submitted during the Entry Period.
2. On the Draw Date all Qualified Entries will be entered into the Player IQ platform supported by Strategy9 and counted. Each Qualified Entry is given a unique number from 1 to "x", where "x" is the number of Qualified Entries. The Prize winners will be drawn at each Draw Time in the chart in the Prize Draws section above.
3. During a Draw, a random number is calculated within the range of 1 to "x" using standard computer code. The Qualified Entry of the Qualified Entrant whose unique number matches the random number generated is selected as a Drawn Entrant and is eligible to win a Prize. The Drawn Entrant does not need to be present at that Facility to win.
4. Gateway will attempt to notify the Qualified Entrant chosen as an eligible Prize winner by phone and/or email.
